Exhibit a professional attitude and demeanor at all times in dealing with the BOD, members, and the general public 2. Demonstrate knowledge and proficiency in the use of the Internet, email, and other computer applications as applicable to job responsibilities. 3. Comply with BOD policies & bylaws 4. Adheres to the chain of command. 5. Maintain and improve knowledge and skills to promote proficiency in the operations of an organized, modern, updated and efficient BOD. 6. Participate in BOD meetings 7. Exhibit time on task and a flexible, cooperative, progressive and hardworking attitude and style. 8. Ensure the integrity, accuracy, and security of all records. 9. Maintain a high level of ethical behavior and confidentiality of information. 10. Maintain a pattern of prompt and regular BOD meeting attendance and perform all duties as assigned effectively and efficiently. 11. Communicate clearly and concisely, both verbally and in writing. 12. Demonstrate appropriate verbal, written, and telephone communication skills. 13. Complete routine tasks with little or no direct supervision. 14. Able to perform essential job functions with reasonable accommodations. 15. Perform other duties as assigned.
